Please use the forms below. Cut the top form to submit with your entry fee of \$15. The two boxes below are to be attached to the back of your entries. One or two pieces of artwork may be submitted for \$15 and all members, including Board and committee members must pay. Prints and reproductions are not allowed in the Prestige Show. Work completed under the supervision of an instructor is not eligible, nor is work done from photos in magazines, calendars, etc. Artwork should have been completed in the last two years. Entries should be properly framed and wired with no sawtooth hangers and use of white or black mats is requested. Water media should be protected by glass or acrylic. Entry of artwork in the Prestige Show is for WTCFA members only. 3-D work will be exhibited in a glass case, and must be no larger than 28 high x 18" wide. Cards for this show are not the same as the cards used in the other hallways at the Community Center. Work may be labeled NFS (not for sale). Set up for accepted work May 1. Take down is August 14. Late entries may not be included in the "Mayors Choice" award.
